Free Legal Services for Senior Residents in Kern County

The Seniors Law Center (SLC) was established at Greater Bakersfield Legal Assistance ("GBLA") in 1968. The mission of the Seniors Law Center is to provide free legal services in civil matters to Kern County's residents who are 60 years of age or older. Our goal is for seniors to maintain dignity and independence in their home by providing necessary legal services.

All services are provided free of charge. Donations are accepted and help defray program costs. However, no senior eligible for services will be denied services based on inability to donate.

To be eligible for services the applicant must reside in Kern County and be 60 years of age or older. There is no income test used to determine eligibility for services. For applicants that do not speak English, we have access to interpreters.

The SLC primarily provides services regarding the following subject matter: Landlord-Tenant law; Consumer Law; Elder Abuse and Neglect; Financial Exploitation; Social Security Matters (apply, appeal, denials, overpayment issues); Debt Collection; Civil legal matters are assessed on a case by case basis; and Guardianship (in such matters the applicable age for eligibility is 55+ instead).


Regarding such subject matter, SLC provides an ear to listen to the legal problems of our seniors and help them determine the best method for addressing those problems including: drafting advanced healthcare directives and financial power of attorney, drafting pleadings, requesting restraining orders, full representation on limited matters, calling the other side, demand letters, cease and desist letters, and suggestions for other resources that would address their problems. Whether we are able to assist or whether the required assistance is outside of the scope which GBLA is able to provide, the SLC tries to help our seniors with finding a direction for resolving their legal situations.
