NOTES:

Pertaining to Planning and Natural Resources Department fees:

- a) \$100 Electronic Permitting Maintenance fee applies to discretionary permits.
- b) Project will be billed on a Time & Materials basis, and total processing costs will be invoiced. The listed fee represents the minimum deposit. For complex or controversial projects, the Director may require a larger deposit. Outstanding balances must be paid in full or work on the project will cease until the account is paid.
- c) At the discretion of the Director, this project may be subject to Time & Materials due to the complexity or unusual circumstances of the case. In that case, we will bill the applicants for processing costs that exceed the filing fee or minimum deposit. Any outstanding balance must be paid in full or we will cease work on the project until the account is paid.
- d) Subsequent preliminary review fees will be required beginning with the fourth and each subsequent review, with the Director's approval.
- e) Major projects - single or multiple tracts proposed by the same applicant on adjacent parcels that total 640 or more acres - will be subject to Time & Materials billing.
- f) Additional mitigation fees for Fire, Rural Crimes, and/or Air Quality may apply.
- g) The State of California increases the Fish and Game filing fees for EIRs and Negative Declarations each January. This fee is collected by the County but sent to the State.

Pertaining to Public Works Department fees:

- 1) Review of Legal Description MAY be required. If determined to be required, minimum deposit must be made and staff costs that exceed the deposit will be billed at \$105/hour.
- 2) Staff costs that exceed the deposit will be billed at \$105/hour.
- 3) Fee includes two reviews. Staff costs will be billed at \$105/hour beginning with the third review.
- 4) The fee covers the first 3 map/plan reviews. Additional reviews as a result of failure to address map/plan review comments or applicant initiated changes, as determined by the director, will be subject to additional map/plan review fees based on time and materials, at a rate of \$105/hour.
- 5) Inspection fees are due at time of construction. If two consecutive compaction tests fail at the same location, additional tests will be subject to additional fees based on time and materials, at a rate of \$105/hour.
- 6) For unusual projects, upon mutual agreement between the director and applicant, an agreement may be executed which outlines a different fee structure.
- 7) At the applicant's option, a county-approved consultant may be used for map and/or plan review to expedite the review process. The consultant fees shall be paid by the applicant, in addition to the County fees.
- 8) One-third of total fee due at time of first submittal, with the remaining two-thirds submitted prior to issuance of grading permit or start of construction related to improvement plans.
